

## **Privacy Policy**

Welcome to the LifeSkills-Coaching.com (“Website”) Privacy Policy. Use of the Website is subject to your acceptance of the Privacy Policy and the Terms and Conditions (“Terms”) found here. This policy informs you about the information we collect and how we use it.

- For any other purpose disclosed by us when you provide the information and otherwise with your consent;
- To comply with any court order, law, or legal process, including to respond to any government or regulatory request.
- To enforce or apply our Terms, and any other agreements, including for billing and collection purposes.
- If we believe disclosure is necessary or appropriate to protect the rights, property, or safety of us, our customers, or others. This may include exchanging information with other companies and organizations for the purposes of fraud protection and credit risk reduction. Sharing Personal Information
